

# Constitution Lapbook

To illustrate your understanding of the Constitution, you will create a lapbook about this document. Your lapbook will contain information and illustrations about the constitution. Templates will be available to help you design and assemble your project.

The lapbook will consist of three parts – the cover, the labeled-interactive categories, and key information. There are 5 categories: Article I, Article II, Article III, Bill of Rights, Other Amendments.

## Cover:

Must include a title and an illustration that reflects the content of the lapbook. Also include your name and hour.
